CONTRACT AGREEMENT

THIS AGREEMENT made this 31st day of May 2019 between NORTHERN MINDANAO MEDICAL CENTER, Capitol Compound, Cagayan de Oro City, Philippines (hereinafter called "the Entity") of the one part and LCD-VISA MANPOWER SERVICES of Lapasan Highway, Cagayan de Oro City, Philippines (hereinafter called "the Supplier") of the other part:


WHEREAS the Entity invited Bids for the Provision of Manpower Services viz. NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


