CONTRACT AGREEMENT

THIS AGREEMENT made this 14th day of May 2019 between NORTHERN MINDANAO MEDICAL CENTER, Capitol Compound, Cagayan de Oro City, Philippines (hereinafter called the Entity") of the one part and MEDICAL CENTER TRADING CORPORATION of Pioneer St., corner Shaw Blvd. Pasig City, Philippines (hereinafter called "the Supplier") of the other part:

4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

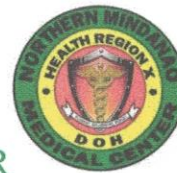
